

Maternity/paternity leave as per rules of Govt. of India/CSB provided that the conditions required for the same is fulfilled.

8.	Other conditions:	1. The Project Assistant will be under the administrative control of the concerned PI/Director of the Institute. 2. The engagement/award of fellowship will be ceased on completion of the project. 3. Unauthorized absence from duties/assigned works for over a period of one month, if any by the Project Assistant fellowship will stand terminated from the date of his/her absence. 4. After engagement as PA/ for execution of the specified project works exclusively, accepting or holding other works with or without remuneration elsewhere is not permissible. 5. The Project Assistant shall have no legal right to claim his/her regularization/appointment by absorption or otherwise against any regular posts or any further contractual engagement on termination of the project. The services of the incumbent shall stand terminated automatically on expiry of the project period given in the sanction order, unless it is extended. 6. The Project Assistant shall settle their claims within one year and in no case after the final settlement of the accounts of the scheme. 7. Project Assistant should register biometric attendance regularly for " CHECK IN & CHECK OUT " at the scheduled Office time. Their project code will be the identification code in Biometric system.
